State Centre of Excellence for management of Severe Acute Malnutrition (SCoE-SAM) is established at Rajendra Institute of Medical Sciences (RIMS), Ranchi Jharkhand to provide technical support to Government of Jharkhand for management of children with SAM at community level as well as at facility Level with Support from UNICEF, Jharkhand.

SCoE-SAM, RIMS invites application from suitable candidate for the position "Consultant- Growth Monitoring and CMAM" on purely contractual basis till 31 December 2021.

- **Name of Post:** Consultant- Growth Monitoring and CMAM
- **Number of Post:** 01
- **Consolidated Honorarium-** 60,000 per month plus travel and communication allowances
- **Essential educational qualification:**
  - Master's in Public Health/Health Policy/Health Administration/Health Management/Public Health Nutrition/ Development Policy, Social Work, Rural Management/Development, Nutrition, Sociology, Demography, or any other related fields.
  - Minimum 4-5 years of experience in working on government projects.
- **Desirable:**
  - Knowledge of Hindi and English language, written and spoken is mandatory
  - Candidate should have his/her own computer/laptop.
  - Knowledge/familiarity with the national flagship programmes (NHM, ICDS and others) and experience of working with Government is an asset
  - Basic computer proficiency and conversant with MS Office and its application, internet, e-mail
  - Good analytical, negotiation and communication (oral and written) skills
  - Preference will be given to those who have already worked in health and/or nutrition related programs
  - Demonstrated ability to work in a multi-disciplinary environment and to establish harmonious and effective working relationships with governmental, non-governmental and civil society organization
  - Should have the ability to travel **extensively (24-25 days per month)** to field to provide training
- **Age Limit:** Not exceeding 45 years
- **Duration:** From the date of joining till 31<sup>st</sup> December with possibility of extension on satisfactory performance only.

  - Provide technical support to West Singhbhum, Godda, Gumla and other districts as directed for implementation of CMAM programme
  - Provide district and block level trainings to government and NGO staff members on growth monitoring, SAM screening and CMAM programme
  - Prepare training report and pre-post test analysis report
  - Undertake supportive supervision (face to face/remote) of Anganwadi centres and Malnutrition Treatment centres as assigned by the organization.
  - Analyze supportive supervision findings and develop report
  - Attend district and block level review meetings and provide necessary technical inputs
  - Any other work assigned by the organization
