This will include identification and conducting anthropometric and body composition assessments of children with severe acute malnutrition (SAM) at different time points, conducting interviews with caregivers, coordinating with frontline health and nutrition workers for keeping records of enrolled children, ensuring quality of data collection and other additional work assigned by Principal Investigator/ Co-PI of the study from the state.
